

Standing Rules Addendum

New/Prospective Members

- All Prospective Members shall be provided with a sponsor as a primary point of contact (POC) for questions and chapter information.
- The sponsor shall be the referring member or if requires, may be a knowledgeable member assigned by the Vice President at the prospective member's 1st meeting.
- The Chapter Secretary shall provide prospective members with a copy of the chapter By-Laws and Standing Rules during their 1st campout.
- The sponsor shall ensure that prospective members are made aware of and are included in all chapter activities, i.e. games, happy hour, meetings, etc.
- The sponsor shall assist prospective members through their guest trial period and for a minimum of 3 campouts after they have become members.
- If a sponsor is unable to attend a campout, they shall ensure that the prospective/new member for whom they are responsible has a temporary POC.
- Prospective members may request to be considered for chapter membership after attending 3 monthly chapter campouts during a 12 month period.
- Sponsors shall brief prospective/new members regarding the following:
 - Uniform Requirements:
 - Full Uniform – Consists of a light blue golf shirt, white slacks/shorts, name tag, white vest and white footwear.
 - Full uniforms shall be worn as required by state and chapter functions or as directed by the presiding chapter officer. e.g. presentation of flags at state rally's, annual change of officers, etc.
 - Partial Uniform – consists of a light blue golf shirt and name tag.
 - Partial uniforms shall be worn as required by state and chapter functions as directed by the presiding chapter officer. e.g. monthly chapter meetings.
 - Hosting duties:
 - Monthly chapter campout hosting duties are a responsibility of all chapter members. These responsibilities shall be rotated through the active member rigs during the camping year and will consist of two (2) member rigs per month.
 - Hosting duties will be voluntary or if required, assigned by the Wagon Master to ensure that all campouts are covered and that all members participate.
 - Chapter Officers shall be responsible for hosting the annual Christmas campout and are exempt from normal host duty rotation during their term of service.
 - Host duties consist of the following:
 - Obtain chapter supply totes from previous month's hosts, replenish as required (reimbursed by chapter with receipts), transport to the monthly campout and provide an updated inventory to the next month's host.

Standing Rules Addendum

- Host Friday and Saturday Happy Hour (set-up).
- Provide anniversary/birthday cake for Saturday Pot Luck dinner.
- Provide Saturday breakfast (reimbursed by chapter with receipts).
- Setup for Pot Luck dinner.
- Provide Sunday continental breakfast (reimbursed by chapter with receipts).
- Perform clean-up as required after breakfast and dinner.
- Maintain weekend activity board.
